We reserve the right to update or amend these terms at any time. Continued use of our website or studio facilities following any changes indicates your acceptance of the updated terms.

2. Using the Arizona Podcast & Live Stream Studio

Clients use our facilities at their own risk and may obtain personal insurance. Arizona Podcast & Live Stream Studio is not liable for injury, illness, or loss incurred during studio use. Clients agree to follow all posted studio rules and conduct guidelines.

3. Parking

When parking, please use your designated parking space if provided. Otherwise, ensure you do not block private entrances or driveways. Lock your vehicle, as Arizona Podcast & Live Stream Studio is not liable for theft or damage to vehicles or their contents.

4. Recording Sessions

Recordings will be delivered via secure online transfer. Once files have been received and/or downloaded by the client, Arizona Podcast & Live Stream Studio is not responsible for loss or corruption of these files. We store raw recordings for 1 month unless prior arrangements are made. Clients are responsible for securing all necessary copyright clearances and licenses.

5. Technical Difficulties

If a session cannot proceed due to technical issues beyond our control, we may reschedule at no charge. If delays or cancellations are caused by the client's technical errors or equipment, regular cancellation charges apply.

6. Studio Bookings

Business hours: Monday–Friday, 9:00 AM–7:00 PM by appointment. Sessions outside these hours may incur a surcharge. Refund / Cancellation Policy: 48+ hours notice: no charge; 24–48 hours: 50% fee; less than 24 hours: 100% fee. Late Arrivals: If you arrive more than 15 minutes late, your session will still end at the originally scheduled time. No-Shows: Failure to arrive without notice will result in loss of the booking fee and no reschedule without full payment.

7. Studio Time

Minimum booking is one hour. If another booking follows yours, sessions must end on time. Exceeding 15 minutes after the end of your booking may incur additional charges.

8. Children

No children under 18 are permitted unless prior written consent is obtained before the session.

9. Conduct Rules

The following are strictly prohibited: abusive behavior, smoking, vaping, illegal drugs, unauthorized alcohol, eating in studio set areas, and possession of any weapons. Alcohol may be allowed for specific events with prior approval.
